RECOMMENDING TO ENJOIN GOVERNMENT AGENCIES TO PROVIDE ASSISTANCE TO THE PHILIPPINE STATISTICS AUTHORITY FOR THE REGISTRATION OPERATIONS OF THE PHILIPPINE IDENTIFICATION SYSTEM

WHEREAS, Republic Act (RA) No. 11055, otherwise known as the “Philippine Identification System Act”, established the Philippine Identification System (PhilSys) to primarily provide a valid proof of identity for all citizens and resident aliens as means of simplifying public and private transactions;

WHEREAS, RA No. 11055 mandates a nationwide registration of demographic and biometric information of all citizens and resident aliens in the Philippines to the PhilSys;

WHEREAS, Section 15 of RA No. 11055 provides that the Philippine Statistics Authority (PSA) shall be the primarily implementing agency to carry out the provisions of the Act, which includes overall planning, management and administration of the PhilSys;

WHEREAS, Section 21 of RA No. 11055 provides that the PSA, together with the Department of Foreign Affairs and other government agencies, shall undertake an extensive information campaign to promote the PhilSys to all citizens and resident aliens;

WHEREAS, Section 15 of RA No. 11055 also provides that the PSA shall collaborate with Local Government Units (LGUs), other government agencies, and Government-owned and Controlled Corporations (GOCCs) in order to ensure the registration and enrollment of all citizens and resident aliens in the PhilSys, including the Indigenous Cultural Communities/Indigenous People and those located in remote localities;

WHEREAS, the PSA targets to start the registration of citizens and resident aliens in the Philippines to the PhilSys on the fourth quarter of 2020;

WHEREAS, the support, assistance, and participation of LGUs and government agencies in the regional and provincial level are instrumental to the success of the registration operations of the PhilSys;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the Inter-Agency Committee (IAC) on Legal Affairs recommends to the PhilSys Policy and Coordination Council (PSPCC) the following:

1. The PSA shall enjoin the government agencies enumerated in Annex IAC-L 02-20200609 to provide assistance in the registration operations of PhilSys, which shall include but not limited to conduct of publicity and information drive.
2. Other than those mentioned in the preceding paragraph, PSA may also request assistance and security from the LGUs, GOCCs and other appropriate government agencies during the registration operations of PhilSys.

To carry out the above purpose, a separate Memorandum of Agreement shall be executed between PSA and the aforementioned agencies.
