COUNCIL RESOLUTION NO. 1 Series of 2018

A RESOLUTION ADOPTING THE IMPLEMENTING RULES AND REGULATIONS FOR REPUBLIC ACT NO. 11055 AND RECOGNIZING THE PARTICIPATION AND COOPERATION OF THE TECHNICAL WORKING GROUP AND OTHER AGENCIES IN DRAFTING THEREOF

WHEREAS, the PhilSys Policy and Coordination Council (PSPCC) is organized to formulate policies and guidelines to ensure effective coordination and implementation of Republic Act No. 11055 entitled "An Act Establishing the Philippine Identification System" otherwise known as the PhilSys Act;

WHEREAS, the Philippine Statistics Authority (PSA) as the primary implementing agency, is mandated to promulgate rules and regulations, in coordination with the members of PSPCC for the effective implementation of the provisions of the Act;

WHEREAS, pursuant to Memorandum No. 2018-142 issued by the National Statistician and Civil Registrar General of PSA, a Technical Working Group was created to formulate the Implementing Rules and Regulations (IRR) of the Act, composed of the members of the PSPCC as follows: Philippine Statistics Authority, National Economic and Development Authority, Department of Budget and Management, Department of Foreign Affairs, Department of Information and Communications Technology, Department of Finance, Department of Social Welfare and Development, Department of the Interior and Local Government, National Privacy Commission, Bangko Sentral ng Pilipinas, Government Service Insurance System, Philippine Health Insurance Corporation, Social Security System, and Philippine Postal Corporation;

WHEREAS, other government agencies such as the Commission on Human Rights, National Security Council, House Committee on Population and Family Relations, Office of the Solicitor General, and the U.P Law Center, also participated in and contributed to the drafting of the IRR;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the Council adopts the Implementing Rules and Regulations for Republic Act No. 11055 entitled "An Act Establishing the Philippine Identification System" and recognizes the participation and

cooperation of the Technical Working Group and such other agencies as the Commission on Human Rights, National Security Council, Office of the Solicitor General, and the U.P Law Center in the drafting of the said IRR of Republic Act No. 11055.
