**PSPCC Resolution No. 23  
Series of 2022**

**APPROVING THE RESTRUCTURING OF PHILSYS INTER-AGENCY  
COMMITTEE (IAC) SUBGROUPS AND THE CREATION OF THE IAC ON  
PRIVACY AND SECURITY**

**WHEREAS**, Section 16 of Republic Act (RA) No. 11055, otherwise known as the "Philippine Identification System (PhilSys) Act", mandates the PhilSys Policy and Coordination Council (PSPCC) to formulate policies and guidelines to ensure effective coordination and implementation of the PhilSys;

**WHEREAS**, pursuant to PSPCC Resolution No. 06, Series of 2019, the Council has approved the creation of the IAC to assist in the implementation of PhilSys;

**WHEREAS**, PSPCC Resolution No. 06, Series of 2019 further identified the IAC subgroups on (1) Communications, (2) Legal Affairs, (3) Technology, (4) Registration and Validation, and (5) Use Cases and Authentication, the member-agencies under each, and their respective functions;

**WHEREAS**, pursuant to PSPCC Resolution No. 14, Series of 2020, the Council has approved the chairpersonships of the IAC subgroups based on their technical knowledge and subject matter expertise to ensure that the groups provide accurate, timely, and substantial inputs to the program's implementation for the consideration of the Council;

**WHEREAS**, in the 30<sup>th</sup> PSPCC Meeting on 29 October 2021, the National Privacy Commission (NPC) proposed the establishment of the IAC on Privacy and Security, which shall recommend to the Council the necessary measures to operationalize data privacy compliance and to monitor the progress of the privacy program and activities of PhilSys including its urgent security reforms;

**WHEREAS**, in the same meeting, the Philippine Statistics Authority (PSA), as the PSPCC Secretariat, requested for inputs from the Council on the proposed restructuring of IAC subgroups and the update of their respective chairpersonships, memberships, and terms of reference;

**WHEREAS**, the five IAC subgroups, through the PhilSys IAC Joint Resolution No. 01, Series of 2022, recommended to the Council the restructuring of the IAC subgroups and the creation of the IAC on Privacy and Security;

**WHEREAS**, the draft PSPCC Resolution was reviewed by the IAC on Legal Affairs and certified as compliant and consistent with RA No. 11055, its Revised Implementing Rules and Regulations, and other applicable laws, rules, and regulations;

**NOW, THEREFORE, BE IT RESOLVED**, that the Council approves the restructuring of the PhilSys IAC subgroups and the creation of the IAC on Privacy and Security;

**RESOLVED FURTHER**, for the IAC on Technology, that the National Economic and Development Authority (NEDA) shall be included as a member;

**RESOLVED FURTHER**, for the IAC on Registration and Validation, that the NEDA shall be included as a member;

**RESOLVED FURTHER**, for the IAC on Use Cases and Authentication, that the NEDA shall be included as a member;

**RESOLVED FURTHER**, for the IAC on Communications, that the chairpersonship shall be transferred from the Department of Finance (DOF) to the Bangko Sentral ng Pilipinas (BSP) in line with the current direction of the program on establishing use cases;

**RESOLVED FURTHER**, for the IAC on Legal Affairs, that the Department of Foreign Affairs (DFA), Department of Social Welfare and Development (DSWD), Government Service Insurance System (GSIS), Social Security System (SSS), and Philippine Postal Corporation (Post Office) shall be included as members;

**RESOLVED FURTHER**, for the IAC on Privacy and Security, that the PSA shall serve as the Chair and that the Co-Chair shall be decided upon the first meeting of the group. The IAC on Privacy and Security shall consist of the following agencies as members:

- (1) PSA – *Chair*
- (2) NPC
- (3) DICT
- (4) NEDA
- (5) DOF
- (6) BSP
- (7) GSIS
- (8) SSS
- (9) Philippine Health Insurance Corporation
- (10) DFA
- (11) DSWD
- (12) Department of the Interior and Local Government
- (13) Post Office

**RESOLVED FURTHER**, that the aforementioned member-agencies shall identify their respective principal and alternate representatives in the IAC subgroups that they have become a part of;

**RESOLVED FINALLY**, that each IAC Secretariat shall facilitate the request for principal and alternate representatives from the agencies identified and finalize its respective terms of reference for submission to the PSPCC Secretariat on or before 30 April 2022.
