**RECOMMENDING THE INCLUSION OF THE DEPARTMENT OF MIGRANT
WORKERS AS MEMBER OF INTER-AGENCY COMMITTEE ON REGISTRATION
AND VALIDATION IN REPLACEMENT OF THE PHILIPPINE OVERSEAS
EMPLOYMENT ADMINISTRATION**

WHEREAS, the Inter-Agency Committee on Registration and Validation (IAC - RV) is one of the PhilSys IAC subgroups created as provided in PSPCC Resolution No. 06, Series of 2019;

WHEREAS, the IAC - RV shall support the development of standards, processes, guidelines and plans for registration including mass registration and steady-state;

WHEREAS, the Philippine Overseas Employment Administration (POEA) is one of the identified member-agencies of the IAC - RV pursuant to the same Resolution;

WHEREAS, the powers and functions of the POEA have been subsumed by the Department of Migrant Workers (DMW) by virtue of Republic Act No. 11641. Specifically, Section 19 of the said Act provides that:

Section 19. Consolidation and Merger of Agencies and Functions

The following agencies are hereby consolidated and merged into and constituted as the Department, and their powers and functions subsumed to the Department which shall assume and perform all their powers and functions:

- a) The POEA, as created under Executive Order No. 247 and Republic Act No. 8042, as amended;

- b) The Office of the Undersecretary for Migrant Workers' Affairs (OUMWA) of the DFA as provided under Republic Act No. 8042, as amended;
- c) All Philippine Overseas Labor Offices (POLO) under the DOLE;
- d) The International Labor Affairs Bureau (ILAB) under the DCLE;
- e) The National Reintegration Center for OFWs (NRCO) under the OWWA;
- f) The National Maritime Polytechnic (NMP) under the DOLE; and
- g) The Office of the Social Welfare Attaché (OSWA) under the DSWD; (emphasis and underscoring supplied)

WHEREAS, the Committee finds it necessary to restructure the IAC - RV to include DMW as a member thereof in replacement of the POEA;

NOW, THEREFORE BE IT RESOLVED, the Committee hereby recommends the inclusion of DMW as a member of the IAC - RV in replacement of the POEA;

RESOLVED FURTHER, that the DMW shall identify their respective principal and alternate representatives in the IAC - RV;

RESOLVED FINALLY, that the IAC - RV shall endorse the above recommendation to the PSPCC for approval.




