**PhilSys Policy and Coordination Council (PSPCC) Resolution No. 27
Series of 2023**

**APPROVING THE INCLUSION OF THE DEPARTMENT OF MIGRANT WORKERS
(DMW) AS A MEMBER OF THE INTER-AGENCY COMMITTEE ON
REGISTRATION AND VALIDATION (IAC-RV) TO REPLACE THE PHILIPPINE
OVERSEAS EMPLOYMENT ADMINISTRATION (POEA)**

WHEREAS, the IAC-RV is one of the PhilSys IAC subgroups created under PSPCC Resolution No. 06, Series of 2019;

WHEREAS, the IAC-RV is mandated under Resolution No. 06 to support the development of standards, processes, guidelines and plans for PhilSys registration, including mass registration and steady-state;

WHEREAS, the POEA is one of the identified member-agencies of the IAC-RV pursuant to Resolution No. 06;

WHEREAS, pursuant to Section 19 of the Republic Act (R.A.) No. 11641, otherwise known as the Department of Migrant Workers Act, the DMW subsumed the powers and functions of the POEA, as created under Executive Order No. 247 and R.A. No. 8042, as amended;

WHEREAS, during the 1st Meeting of the IAC-RV held on 07 March 2023, the Committee agreed to endorse to the PSPCC, for approval, the inclusion of the DMW as a member of the IAC-RV in replacement of the POEA;

WHEREAS, under IAC-RV Resolution No. 01, Series of 2023 dated 11 May 2023, the IAC-RV resolved to recommend to the PSPCC the inclusion of the DMW as a member of the IAC-RV to replace the POEA and for the DMW to identify and designate its respective principal and alternate representatives in the IAC-RV;

NOW, THEREFORE, BE IT RESOLVED, that the Council hereby approves the inclusion of the DMW as a member of the IAC-RV to replace the POEA;

RESOLVED FINALLY, the Council hereby authorizes the DMW to identify and designate its respective principal and alternate representatives in the IAC-RV.


